

## THE CHARITABLE GIFT ANNUITY IS A PLANNING TOOL THAT RECOGNIZES THE REWARDS OF GIVING BEGIN WITH THE DESIRE TO MAKE A GIFT.

Through Clemmons Moravian's GiftLegacy program, members can create a charitable gift annuity by transferring an asset to the Moravian Ministries Foundation (MMFA). In turn, the MMFA makes payments to the donor for life. At the donor's death, Clemmons receives the remainder.

In addition to the satisfaction inherent in the act of giving, the gift annuity adds a tangible benefit in the form of attractive income payments. The specific rate is based on the age of the donor; please see the back panel for details.




## GIFT ANNUITY FROM STOCK

While a gift annuity can be funded in a number of ways, let's examine the benefits of transferring an appreciated block of stock to charity.

The gift annuity graphic below shows the highlights. Not only is there an immediate charitable income tax deduction, but it is possible to bypass a portion of the capital gains tax on the sale of an appreciated asset.

In addition, the gift annuity may significantly increase income. Many donors appreciate the fixed payments. And the benefits don't end there; of the annual income payment, a portion of the payment may be tax-free.
